I have an application that is meant to run in the background on a server and notify users via email when some data changes. Currently I have that running on a Windows Service but I am starting to run into issues with the windows service becoming unresponsive and hanging. I'm wondering if there is a better, more Windows Server-y way to do this? I was looking into Powershell, Task Scheduler, and Quartz.NET, but I'm not sure if one of those is a better fit. If so, I'm wondering if there's a difference between running a windows service or Task Scheduler task on Windows 8/server 2012 vs Windows 7/server 2008. A: You're better off not using the Windows Service. If you can't think of anything else, Quartz.NET will definitely do what you need. For task scheduling, I'd also suggest you look at PowerShell. It's the new "batch" scripting language, and will allow you to start, stop, and restart jobs, as well as monitor them.
